## Tidal Wetlands Planning Grant Award – George Yurek

100% funding for the project is now complete – Time to celebrate \$1.4M investment in the community!

Maryland DNR's Chesapeake & Coastal Service in the amount of \$433,363; grant contract to be finalized with Talbot County before end of March.

National Fish & Wildlife Foundation Chesapeake Bay Program in the amount of \$979,267.

Total of \$1,412,630 will fund 100% of the project budget resulting in a substantial new asset that will eliminate erosion, and threat of storm surges to sewer infrastructure and private property. The environmental and recreational aspects of the project will support TOCCA as one of the most desirable communities in which to live in the Bay Hundred region.

## Next Steps and Project Timing.

Since the fall of 2019, the project has focused on design, grant funding, Federal/State/Local permitting, and community engagement in the form of monthly Board meetings, 4 special purpose community meetings, letters from the President, project poster boards and write ups, and project documentation posted on the TOCCA website.

With funding now in place, the project will move to the pre implementation phase including finalizing grant contracts between Talbot County and the funding agencies and conducting a rigorous competitive bidding and contracting process with marine contractors licensed by the Maryland Department of the Environment.

The MDE permit for the project will only allow construction between mid-October and mid-March. The current plan is to start construction in October 2024. The project budget includes funds for our project engineer (Bayland Consultants and Designers) to provide professional services to manage the competitive bidding process and to provide construction management services. Both items will help to ensure that the project is built according to all design specifications, in a timely manner, and within budget.

A fifth community meeting will be scheduled in the spring with a focus on what to expect during construction.

Project documentation as of March 2024 can be found on the TOCCA website under member interests including an update to the Project Details and Strategy write up. A new poster board will be set up at the yacht club before the end of March with illustrations on what to expect during the six month construction process.

In the interim, any questions on the project can be directed to project team members Ian Jones, George Yurek, Tommy Gamble, Tom King, and Ron Tipa.

# Marina & Causeway Operations – Tommy Gamble

**Replacing B dock:** We have a contract with Meeco Sul

We have a contract with Meeco Sullivan to build the new dock. It is ready to sign when funding is available.

We have a contract with Island Marine Construction to install the dock. It is ready to sign when we order the dock.

We have a building permit from Talbot County.

We met with Justin from Triple J Electric to install the electricity on B dock. They were the company that did the new transformer and wiring on C dock. He is contacting the plumber we used when we replaced the plumbing on C dock. He will be able to do the job at the end of April but will have to come back in about a year to replace the electrical boxes on the causeway. There is a 50 week wait on

that size box.

There is about a five week delivery on the B dock. If we have the funds within the next week, we can order the dock and install it before the 2024 boating season.

Removing the wave attenuator and replacing it with a timber jetty: We submitted permit applications to the state and federal agencies in October 2023. We should receive permits around October 2024. We will replace the wave attenuator after that.

Replacing C dock: After replacing B dock we will make a decision on when to replace C dock.

Dredging: After the timber jetty is installed will decide when to dredge. The dredging permit is part of the timber jetty permit.
